TERMS AND CONDITIONS OF SALE

A. BACKGROUND

Airport of Rodrigues Ltd (ARL) shall conduct the sale/disposal through bidding of two (2) vehicles.

B. SCOPE OF PUBLIC AUCTION

Sale / Disposal of the mentioned motor vehicle shall be on "AS IS WHERE IS" basis and is open to all members of the public over the age of 18.

C. PROCEDURES AND REQUIREMENTS

1. COST

Prices quoted should include all taxes, transportation, cart away and additional costs. The prospective bidder shall bear all costs in the preparation and delivery of their bids (ARL shall in no case be responsible or liable for these costs regardless of the outcome of the bidding process)

2. Publication

ARL shall publish the invitation to bid on ARL website and post in at least two local newspapers to invite prospective bidders in the Public Bidding.

3. AMENDMENTS OF TERMS AND CONDITIONS OF SALE

Should any of the information and/or procedures contained in this Terms and Conditions of Sale be amended or replaced, all prospective bidders shall be informed of such amendments or replacements through issuance of appropriate communiqués.

4. DISCLOSURE

All prospective bidders are requested to provide information of their authorised representatives, contact numbers home/business address and email address.

5. FLOOR PRICE

The minimum floor price for the two motor vehicles is as follows:

The winning bidder shall pay, in addition to the purchase price, any taxes, fees, charges of any kind or nature whatsoever levied in connection with the sale of the motor vehicle. All expenses incidental to the withdrawal of the motor vehicle shall be borne the winning bidder.

6. CORRECTION OF BIDS

Erasures / modifications shall be avoided or duly initiated by the bidders.

7. LATE BIDS

No bids shall be accepted after the deadline. late bids shall be automatically disqualified.

8. VALIDITY OF THE PROPOSAL

A bid will be deemed valid for a period of sixty (60) calendar days from the date of bid opening. A bid with a shorter validity period shall not be considered.

9. SUBMISSION OF BIDS

Bidders shall submit their Bid in a single package/envelope and shall contain:

- a. The Quotation form containing their bid price denominated in Mauritian rupee
- b. Photocopy of NID for the Bidder or photocopy of the authorised representative and authorisation letter for the representative of the Bidder.

10. FAILURE OF BIDDING

Bidders whose bids fall below the Minimum Floor Price set by ARL shall be disqualified. In case there are no bids received or all the bids are disqualified, ARL shall declare a failure of bidding. After three (3) failed biddings, ARL shall enter into negotiated sale of the two (2) vehicles. Bidders who have participated during the three (3) failed auction shall be given priority in the negotiation, while new participants shall only be allowed to participate in the negotiation after a failed negotiation and provided they have paid the non-refundable fee of Rs 500 in cash.

11. ISSUANCE OF RESOLUTION, LOA AND CONTRACT

- a. The bidder with the highest bid price as determined by ARL shall be declared as the "winning bidder". In case of non-compliance in the terms of payment of the Highest Bidder, the sale shall be awarded to the Second Highest Bidder based on the conditions set forth in the Terms and Conditions of Sale. The process may continue until a new Winning Bidder has been declared, unless ARL declares otherwise.
- b. In case of tie, ARL shall resort to a non-discretionary selection criterion (toss coin or draw lots) to determine the winning bidder.



The Airport Manager shall issue a Letter of Award to the Winning Bidder. The Letter of Award as the case may be together with this Quotation form shall constitute the contract between ARL and the Buyer.

- c. Within one week (7 days) counted from the receipt of the Notice of Award, the Winning Bidder shall pay the balance of his/her Bid Price to ARL and the parties shall execute the contract signing of the Deed of Sale. Payment shall be in the form of cash or check, issued by a reputable bank payable to the Airport of Rodrigues Ltd.
- d. If the winning bidder fails to pay the Winning Bid Price in full on the scheduled date, the second Bidder may be declared as the winning bidder. The process may continue until a new Winning Bidder has been declared, unless ARL declares otherwise.
- e. All items should be collected at Airport of Rodrigues Ltd, Plaine Corail Airport, Plaine Corail, Rodrigues

12. RESERVATION CLAUSE

ARL reserves the right to reject any or all bids, or to waive any defect, informality or minor deviations thereon, which do no affect the substance, validity of any or all of the bids without any liability to any party for any action or decision taken by virtue of this reservation.
